

AGREEMENT FOR THE ELECTRONIC PUBLICATION OF AUTHOR'S DISSERTATION

1	Partial assignment of copyright ownership	
1.1	The Author provides NTNU a royalty-free, non-exclusive right to make available the Authors dissertation:	
	Hereinafter referred to as the "Author's dissertation", available in electronic form via NTNU's institutional archive, which will thereby result in the publication of the Author's dissertation on the Internet.	
1.2	The Author is aware of and accepts the extent and importance of the copyright laws and the subsequent publishing via the Internet	
2	NTNUs Obligations	
2.1	NTNU will make the dissertation (or part of the dissertation) available in the form in which it was submitted to NTNU, with text, tables, graphics, images and more, but with the technical adjustments necessary for publishing on the Internet. NTNU is not responsible for proofreading the dissertation or verifying that the submitted version corresponds with any previous version / draft.	

- 2.2 NTNU will protect the Author's dissertation against being changed by unauthorized/third parties, in accordance with NTNU's current security requirements.
- 2.3 NTNU's rights to the dissertation in relation to the author are governed exclusively by this Agreement. If the Author's dissertation or parts thereof have been previously published in journals / publications, or whether for other reasons there exist other licensees of the Author's dissertation, then NTNU will obtain permission from them. The obligation described in the preceding sentence arises only if the Author contributes to this collection and provides all the necessary information to NTNU. (*It is recommended that the Author prepares an annex to the agreement containing the information regarding the existence of any external licensees (journal, publisher, co-authors, etc.), as well as other necessary information about the author, institution, etc.). If the author has such information on the contract date, then the information shall be specified in a separate annex Annex I.*
- 2.4 NTNU will not have right of use beyond those expressly stated in this agreement.

3. The Author's Obligations

- 3.1 The Author should follow NTNU guidance for publication.
- 3.2 The Author shall in the event of entering into agreements with other (typically journals and publishers) on the transfer of the right to publish the dissertation or articles included in this, always make sure to preserve and protect the NTNU's rights under this Agreement.
- 3.3 The Author warrants that he / she is the author of the dissertation and has complete control over this in its entirety, including articles, with the exception of the Author shall give written information to NTNU after **Annex I**. The same applies to material that is attached or otherwise connected the thesis, such as attachment or through linking or other technical procedures.
- 3.4 The Author warrants that the dissertation contains no material that can be considered to be contrary to Norwegian law or contains links or other links to such material.
- 3.5 If NTNU should be made liable to a third party because the Author does not meet his/her obligations under this Agreement, the Author shall indemnify and hold NTNU harmless from any such liability.

4 Prints/copies

- 4.1 NTNU has the right to publish the work of the Author on the Internet in such a way that it is possible to take a print of the document. NTNU also has the right to produce individual paper prints and other copies of the Author's dissertation for internal use at NTNU
- 4.2 NTNU can also, at the request of a customer, make individual prints of all or part of the dissertation, and sell it at a price equivalent to cost.

5 Transfer of the Agreement

- 5.1 NTNU will only be able to transfer its rights and / or obligations under this Agreement to third parties if the Author's interests are protected.
- 5.2 Neither party shall be entitled to compensation from the other party for publication under this Agreement, except as otherwise provided expressly by this.

6 Termination of the Agreement

- 6.1 NTNU has an unlimited right to cancel the publication of the dissertation.
- 6.2 The Author has the right to terminate the agreement by giving NTNU written notice of termination. NTNU will remove the dissertation from their pages as soon as possible and no later than 6 months after receiving a written notice of termination.

7 Treatment of personal data

7.1 The Author gives his consent to the NTNU data processing personal information about him/her, including the use of databases and search tools on the Internet, to enable the publishing and archiving in accordance with this Agreement. The consent includes permission to disclose relevant information for use in external databases or search tools, regardless of what country they are established in. The Author agrees that his / her name and other personal information that is directly related to authorship made available on the Internet, however, limited to the extent consistent with good practice.

Responsibilities:

8.1 NTNU is in no way responsible for the content of the published document or author's behavior / actions as a whole. NTNU has no liability for damages in connection with this Agreement, unless the damages caused by willful misconduct or gross negligence of NTNU or a party which NTNU is responsible. This responsibility will under no circumstances cover indirect damage or losses.
